The categories of schools set out in information document 23/2007 are essentially descriptions of schools in Wales as they exist. The definitions are used for statistical purposes and are collected from schools, via local authorities on an annual basis. Schools are asked to identify which description most closely fits them at the time data is collected. Governing bodies and head teachers may seek assistance from the local authority in deciding which category best describes them. The data collection informs the national picture and is intended also to assist local authorities in identifying gaps in provision in the light of parental demand.

Regulations made under the School Standards and Framework Act 1998 set out which changes to schools necessitate the publication of statutory proposals. Certain changes to schools in respect of the language used for teaching and learning require full consultation followed by the publication of statutory notices, and such proposals must be brought forward by the local authority in the case of community schools and the governing body in the case of voluntary and foundation schools.

I have made clear my intention to focus on children's literacy.

Through the Foundation Phase we are ensuring that children are immersed in language experiences and activities to boost their language, literacy and communication skills

In 2009-2010 £13.2m funding was allocated to support the continuing delivery of our national "Basic Skills Strategy" which is currently being reviewed and revised. This included key programmes for early years, schools, teachers and adults as well as innovative campaigns such as Read a Million Words in Wales.

Through this strategy effective use has been made of Welsh Assembly Government funding sources including Strategic Intervention Grants (SIGs) to all Local Authorities to support "catch-up" programmes for children falling behind in their learning.

All higher education institutions are autonomous bodies, with responsibility for their own academic and administrative affairs, including pay and conditions. Recognising the importance of the Foundation Phase I have ensured that a total of £76m is available to local authorities in 2010-11, an increase of £22m on 2009-10. This brings to £170m the funding allocated to the first three years of rollout.

Welsh Assembly Government funding has enabled schools to employ an additional 3,700 staff in the first two years of rollout and local authority plans indicate that this will increase to 4,500 in 2010-11. The funding is being used primarily for front line services. As a result the all-Wales average adult/pupil ratio of 1:8 has been achieved for 3 to 5-year-olds and plans are in place for the 1:15 ratio to be secured for 5 to 6-year-olds as they enter the Foundation Phase from September 2010.

Early feedback points to improvements in the quality of teaching and learning as a result of the provision made for the Foundation Phase. In addition, Estyn has confirmed that through the Foundation Phase practitioners are offering well-planned practical activities that both challenge children and promote the development of their skills.

Implementation arrangements are therefore on track and Estyn has confirmed that practitioners are fully committed to the principles and philosophy of the Foundation Phase.

Paul Davies (Preseli Pembrokeshire): What steps is the Welsh Assembly Government taking to combat the failures to meet statutory requirements in teaching Welsh at Key Stage 4 level. (WAQ55828)

As underlined in our Welsh Medium Education Strategy I am fully committed to increasing opportunities for learners to reach fluency and use the Welsh language in their communities, families and workplace.

The importance of Welsh is therefore recognised in the school curriculum with the requirement that Welsh is provided for all pupils in compulsory education. The programme of study set out in Welsh in the National Curriculum for Wales requires schools at Key Stage 4 to build on the skills, knowledge and understanding at Key Stage 3 through an intregrated programme of oracy, reading and writing. Given that Welsh at Key Stage 4 is part of each individual's 14-19 learning pathway, provision is designed to encourage the abilities of young people as learners and their desire to access future learning opportunities.

Achievement and the quality of provision in Key Stage 4 in schools are subject to regular inspection by Estyn with schools required to take action to address any areas for improvement identified by the Inspectorate.

Paul Davies (Preseli Pembrokeshire): What strategies has the Minster put in to place to promote Science for secondary school pupils. (WAQ55831)

Answer issued on 27 April 2010

The revised school curriculum was introduced from September 2008 following extensive consultation with practitioners across Wales. The importance of science is recognised with the requirement that it is provided for all pupils in compulsory education. The programme of study set out in Science in the National Curriculum for Wales provides schools with a detailed programme of study for each Key Stage. In addition, schools have been provided with detailed guidance to support the planning, teaching and delivery of Science at Key Stages 2 and 3.

We continue to work with local authorities and secondary schools to support the delivery of the curriculum. This includes support for the external moderation of teachers' assessment of standards in Key Stage 3 and provision of guidance on developing higher-order scientific enquiry skills.

Answer issued on 27 April 2010

The school curriculum in Wales provides a range of opportunities for learners to learn about healthy eating.

In the Foundation Phase, the 'Personal and Social Development, Well-Being and Cultural Diversity' area of learning provides children with the opportunity to develop an understanding of the importance of food in their daily lives.

In the national curriculum, the place of food in design and technology has been given greater significance and status. At Key Stages 2 and 3, practical food preparation skills have been made compulsory and food has been made a compulsory material. At all key stages in physical education, the 'Health, fitness and well-being activities' area of experience requires learners to be given opportunities to identify how to eat and drink healthily in order to meet the energy requirements of different activities and to find out how exercise affects the body. In science, in 'Interdependence of organisms' at Key Stage 2, learners should be given opportunities to study the need for a variety of foods and exercise for human good health. At Key Stage 3, they should be given opportunities to study how food is used by the body as fuel during respiration and why the components of a balanced diet are needed for good health.

In the basic curriculum, the 'Health and emotional well-being' theme in the framework for personal and social education has a clear emphasis on food and the importance of healthy eating, requiring learners to understand the relationship between diet, exercise and good health.

Support materials for schools are being produced to accompany the school curriculum and the guidance document Food and fitness in the school curriculum in Wales has recently been sent to schools as part of this package.

Schools also consider a whole school approach to food and fitness as part of their work linked to the Welsh Network of Healthy School Schemes; and, primary schools have been receiving visits from our Cooking Bus since September 2006.

The recently launched Welsh-medium Education Strategy includes clear actions for tackling any weakness in provision. We expect local authorities to plan effectively for Welsh-medium provision, in conjunction with their Children and Young People's Partnerships. They will report on their Welsh-medium, bilingual and Welsh-language education strategy and planning to the Welsh Assembly Government, including whether they have achieved specific outcomes.

The Strategy and Implementation Programme also outline actions to tackle weakness in performance. These are more evident with Welsh second language (Estyn reports note that this remains a poorly performing subject).

For those being educated through the medium of Welsh, the Strategy and Implementation Programme target action to raise standards in Welsh-language literacy. We shall also expect an increase in the Welsh-medium element in bilingual schools in order to improve learners' fluency in Welsh.

Other actions include developing more effective methods of delivery, improving the training of practitioners at all levels, and identifying and sharing best practice as an integral part of the School Effectiveness Framework and the Quality and Effectiveness (post-16) Frameworks.

Answer issued on 30 April 2010

The Deputy Minister for Children (Huw Lewis): The Children and Families (Wales) Measure makes statutory provision, to take forward the Welsh Assembly Government's commitment in terms of child poverty, and to take forward its strategy for vulnerable children by bringing forward legislation to provide greater support to families where children may be at risk, and strengthened regulatory enforcement in childcare settings.

Part 2 of the Measure, Child Minding and Day Care for Children, takes the opportunity to use powers devolved under the Government of Wales Act 2006 to consolidate and improve existing child minding and day care legislation for Wales, making the law in these areas more accessible and easier to understand. Part 2 also includes new measures which strengthen regulatory enforcement in childcare settings.

The Welsh Assembly Government will be consulting on the childminding and day care regulations which fall from the Measure during the summer months.

In addition, following requests for additional guidance we have been working closely with key stakeholders in Local Authorities to produce a Childcare Sufficiency Assessment toolkit for Wales. The toolkit aims to assist Local Authorities with their duty under the Childcare Act 2006, to produce a Childcare Sufficiency Assessment every three years with at least an annual review. The toolkit in now in its final stages and will be available to key partners in May.

We will also be considering how best to develop childcare provision across Wales and to improve quality, as part of our overall approach to helping those families most in need.

At present the whole of GB remains in a Protection Zone for BTV8. Wales, as part of the UK Member State, is in discussion with the European Commission in regard to re-designating the current GB Protection Zone a BTV8 Lower Risk Zone. This would allow vaccination against BTV8 to continue whilst also putting in place additional measures to protect against the risk of bringing in animals which may be carrying the disease. Vaccination is the only effective means of protecting animals against Bluetongue and the Welsh Assembly Government continues to encourage farmers in Wales to vaccinate.

Further GB surveillance for all Bluetongue serotypes will be carried out in November which could support the case for disease freedom in 2011.

Susceptible animals that move to UK from other Bluetongue affected EU Member States continue to be post import tested for all Bluetongue strains.

Lorraine Barrett (Cardiff South and Penarth): How many letters or signatures on petitions has the Minister received objecting to a badger cull in Wales. (WAQ55799)

Since 8 April 2008 I have received 40,000 representations both supporting and objecting to the TB Eradication Programme which includes a limited cull of badgers in a pilot area. This includes 12 petitions/campaigns and correspondence received during a 14 week public consultation on the Tuberculosis Eradication (Wales) Order 2010. The number of signatures on petitions/campaigns represents 90% of all representations received on this issue. The majority of the letters and signatures were from individuals living outside Wales.

Brynle Williams (North Wales): Will the Minister provide an update on the progress of the Welsh Assembly Government's review of farming red tape. (WAQ55811)

Answer issued on 30 April 2010

I am pleased to report good progress. Reducing/combining inspections has been our top priority with three main points of attack. First, working with Animal Health and private vets to deliver combined TB and WAG cattle inspections. Second, working with Local Authorities who, where appropriate, will not inspect where WAG has already done so. Third, delivering a similar arrangement with the Farm Assured Welsh Livestock Scheme (FAWL).

Other practical work linked to reducing bureaucracy continues, most recently with the delivery of a simple solution to address the Food Chain Information (FCI) requirements for Cattle and Sheep in Wales.

Brynle Williams (North Wales): Will the Minister provide an update on the progress of the Local Sourcing Action Plan. (WAQ55812)

Answer issued on 30 April 2010

The Local Sourcing Action Plan sets out our agenda for increasing the amount of local food purchased by the consumer, public sector organisations and the hospitality sector.

Significant progress has been achieved with over 75% of the plan completed. Some projects are more long term in their impact and aspirations and these are making good progress. There are many partners involved in the delivery of both plans which require cross departmental co-operation and working across the sector.

Lorraine Barrett (Cardiff South and Penarth): Will the Minister clarify whether lactating female badgers will be exempt from being culled or will the cull be indiscriminate. (WAQ55929)

Answer issued on 07 April 2011

We recognise the welfare implications of orphaning dependent young in the sett. For this reason we will be implementing a closed-season in the pilot area, during which no badgers will be culled. This is in line with that which was adopted for the Randomised Badger Culling Trials (RBCT) in England, where the closed season ran from 1 February to 30 April each year. The Final Report of the Independent Scientific Group (ISG) concluded that the closed season adopted for the RBCT appeared highly effective at limiting the numbers of females caught that had dependent cubs: of 4,617 adult females captured in 2000-2005, only 171 (3.7%) were actively lactating.

It will not be possible to handle live, cage-trapped badgers to determine their sex or whether they are lactating. This information will however be recorded following despatch and be used to inform any decision on changing the closed-season in the future.

Lorraine Barrett (Cardiff South and Penarth): What consideration has the Minister given to the view set out in the report by Imperial College London, that the long term effects of a cull will be an increase in the prevalence of bTB amongst badgers. (WAQ55930)

Eleanor Burnham (North Wales): What plans does the Welsh Assembly Government have to replicate the Scottish system and place a statutory duty on fire brigades to respond to flooding in Wales, as set out in the current fire Brigade Union's campaign. (WAQ55800)

Answer issued on 27 April 2010

Any response to a major flood event will inevitably involve an operational response from the Fire and Rescue Service. The Welsh Assembly Government has consulted the three Chief Fire Officers in Wales who are of the view that provided there is clarity of purpose, guidance and the availability of necessary resources to carry out flood rescue a statutory duty is not required.

Since devolution of the Fire and Rescue Service to Wales, a major capital investment of £2.2 million has been made to provide four High Volume Pumps and special vehicles to the Fire and Rescue Services, which have been used to great effect in the serious flooding of 2007 and 2008.

A further £800,000 of funding has been provided over the last two years to the three Fire and Rescue Services in Wales to procure water rescue equipment and training to bring its teams up to national consistent standards.

Jenny Randerson (Cardiff Central): What action has the Minister taken to support community pubs and does he plan to bring forward any measures to support community pubs and are there any specific financial allocations in the 2010/11 budget for measures to support community pubs. (WAQ55809)

Answer issued on 27 April 2010

Whilst the Welsh Assembly Government is committed to tackling the misuse of alcohol, we recognise the importance of local pubs to their communities. There are a range of measures being undertaken, and finance available, across portfolio areas that will support community pubs.

Within my portfolio, we have enhanced the Small Business Rates Relief available for small independent public houses for one year from 1st October 2010 to 31 September 2011. Businesses with a rateable value up to £6,000 will receive 100% relief for that year, whilst those with a rateable value of £6001 to £12,000 will receive relief tapered from 100% to 0%. Details of the tapering are still being finalised.

Also, within my portfolio area, the Post Office Diversification Fund can be used to relocate post office services into a local pub where the community has lost its post office for any reason other than compulsory closure. In order to apply the pub must have a contract with Post Office Ltd to provide post office services.

Recognising the importance of maintaining the local pub in rural areas, the Assembly Government has previously awarded a grant to 'Pub is the Hub', an independent advisory trust, to undertake a research project. Their report made a number of recommendations to help secure the future of pubs in rural Wales. Work has been taken forward on this and many rural pubs are now eligible for the Rate Relief Scheme, as detailed above. Officials in the Department for Rural Affairs are taking forward the remaining recommendations.

I'm aware that a number of Axes 3&4 Local Partnerships, established through the Rural Development Plan for Wales 2007-2013, have also been in discussion with 'Pub is the Hub' to explore ways in which they could contribute to the development of their rural areas. For example, Cadwyn Clwyd are already working with 'Pub is the Hub' to deliver projects for rural communities in Denbighshire, including supporting them to act as co-operatives to buy the pub to ensure it is retained as a centre of services for their local area.

Assembly Commissioner for the Assembly and the Citizen, Peter Black AM: Developing the Assembly brand was necessary as a result of the Government of Wales Act 2006, which secured the separation of the National Assembly for Wales (the parliamentary body) and the Welsh Assembly Government (the executive) in law for the first time.

It was clear that people did not understand the distinct purposes and functions of the two bodies. So that people will engage with the Assembly as a legislative and scrutiny body which holds the Welsh Government to account, the distinction needs to be understood. Branding to emphasise this distinction is a tool to help the Assembly to secure better engagement with the people of Wales. The work on the brand also demonstrates the Assembly's commitment to producing information that is accessible, consistent and engaging.

The National Assembly's publication budget (which includes the cost of branding) meets the costs of all printed materials. In 2008-09, the total spend on branding and consequent publication requirements was £79,805. Within that figure, £28,525 was paid to a professional design agency (Departures) for the creation and development of the new brand to be used across the Assembly.

The branding work was approved by the Commission in July 2008. Provision for a proportion of this expenditure had already been included in the Commission's budget for 2008-09 and approved by the Assembly. Additional costs were contained within the agreed budget and resources for that financial year.

The cost of producing resources, including business cards and display materials, in the new brand style amounted to £22,000 and this was paid from the 2009-10 publications budget. Some of these printing costs would have been incurred in any event to replace and update existing material.
