The Deputy Minister for Children and Social Services (Gwenda Thomas): The Welsh Government was notified by Local Safeguarding Children Boards of 102 Serious Case Reviews for children between January 2003 and December 2012. Of these, 89 have been completed and 13 are on-going. Table 1 breaks this information down by local authority area. Some local authorities have merged their Local Safeguarding Children Boards over this period.

The Minister for Health and Social Services (Mark Drakeford): I have not yet had any discussions with either Welsh Government or Westminster Ministers regarding this matter as responsibility for this legislation cuts across several Welsh Government Departments.

My officials from both the Pharmacy and Substance Misuse teams will be working closely with the Minister for Enterprise, Science and Transport's officials to ensure the implications of such proposals for those taking prescribed medication are fully covered within the Welsh Governments response.
