'Calls on the Minister to consider placing a duty on Assembly Sponsored Government Bodies (ASPBs) and local authorities to report annually on the amount of local produce they have procured.'

'Recognises local food procurement by the public sector as a vital means of support for the small family farms that are prevalent in the agricultural sector in Wales.'
