Leighton Andrews: The School Standards Unit will, as part of its regional stock takes, assess the use and impact of the grants. In addition, we have commissioned an evaluation of the Grant, and an interim report in November will inform actions to improve delivery, both in terms of process for administering the grant, and to maximise the impact of the grant. Two further reports will be published in each of the next two years with workshops arranged to share findings with key stakeholders following receipt of the final report.

Schools through their consortia submit spending plans outlining how the Pupil Deprivation Grant (PDG) is being used to support pupils from poorer backgrounds. The funding is delegated directly to schools to enable them to determine effective interventions and to meet local needs. Each plan details how pupils will be supported and sets out the expected impact upon performance for their school or cluster.

The spending plans are based on guidance issued by the Welsh Government outlining targeted interventions that help disadvantaged pupils. The guidance makes it clear that the PDG can only be used for interventions to support pupils from deprived areas. For example, schools may adopt whole school strategies in terms of data tracking, but should use that data to identify interventions to support children from disadvantaged backgrounds.

The funding is granted on a per capita basis for those pupils eligible for Free School Meals. The quantum of funding, and therefore the interventions designed by schools, may vary widely, depending on the number of eligible pupils.

Predominantly the PDG funding for this year is being used to support staff costs - the majority being employed to engage Teaching Assistants and Learning Support Assistants to support a range of programmes. Some schools are using PDG funds to support activities that target attendance, behaviour management, look at wider well-being, or support the engagement of parents/ developing parents' skills in supporting their children's learning.

Two key factors highlighted in the guidance which will form the basis of the schools spending plans are maximising both teacher quality and school quality. The most recent guidance, issued in its draft format at present, has a section on How to Use the Pupil Deprivation Grant with interventions that include, for example, feedback, learning to learn, peer tutoring, parental involvement, promoting leadership, homework and extra curricular opportunities. The schools are also given advice as to which intervention might best work for their particular circumstances.

Guidance is also included on working with Communities First Clusters, supported by the Communities First PDG matched fund. Further support will be provided at workshops, the first of which will be held at a conference on March 7 in collaboration with the South East and South Central Consortia.

Leighton Andrews: Four pilot projects, involving 8 local authorities, to test alternatives to the current SEN framework were established late 2009. The initial development phase concluded in autumn 2011 since when two further phases of the pilots have been agreed to test tools and systems and to look at how the individual elements work as a whole system including the key aspect of the reform agenda, multiagency planning.

The local authorities involved are Carmarthenshire, Torfaen, Caerphilly, Flintshire, Cardiff, Newport, Bridgend and Pembrokeshire and the tools and systems being further tested now include:

- the Individual Development Plan (IDP) Planning Process, which is intended to replace the existing statement of SEN, and the web based tool which supports this;
- a quality assurance system, which is a comprehensive framework for the self evaluation, monitoring and evaluation of educational provision for children and young people with additional learning needs;
- the roles and responsibilities of the Additional Learning Needs Co-ordinator (ALNco).

In addition a programme of 'person centered planning' training is being rolled out.

Where relevant, links are being made to other providers, such as the voluntary sector, and other programmes, such as Early Support and Families First

Through a Programme of Action Research, an evaluation report and a costs analysis of the developmental phase of the pilots was published in June 2012. A further report on the second phase of the Pilots is due to publish within the next few months.

Leighton Andrews: The fall in Welsh applicants to Welsh HEIs is due principally to a significant drop in the number of 18 year olds in Wales. These demographic factors are reflected in the modelling for all student finance budgets.

The latest UCAS figures also show a significant increase in the number of students from other parts of the UK applying to study at Welsh HEIs, potentially bringing around £75m into the Welsh higher education system over the next three years. Although it's important not to read too much into application data at this point, these figures show our policy on tuition fees is sustainable and affordable.

The Minister for Health and Social Services (Lesley Griffiths): One of the principles of Families First, as outlined in the Programme Guidance, is that services should be local, identifying the needs of local communities and developing appropriate service delivery to meet those needs, with particular regard for the opportunities to link with Flying Start and other programmes.

Families First, Flying Start, Communities First and the Integrated Family Support Service will, together, help deliver our vision for a citizen model of accessible, seamless service delivered in the community by skilled people working together to ensure better matching of provision to individual needs.

In developing their Families First plans, Local Authorities were specifically asked to consider how Families First linked with the Flying Start programme.

The report from the Families First pioneer stage shows Local Authorities are working to provide seamless interventions by bringing together different programmes including Flying Start. Many Local Authorities report improved links with associated programmes such as Flying Start due to impetus from the Families First programme.

All Local Authorities have developed a Team Around the Family (TAF) as part of Families First; we are the only UK country that requires all Local Authority areas to take this approach. TAF requires effective, joined-up support for families from the earliest possible point, typically involving a multi-agency approach across the spectrum of agencies and other programmes. This should provide a coherent and cohesive approach to supporting families and individuals.

We are continuing to drive greater join up between programmes to realise the combined potential benefits. For example, we have secured funding from the European Social Fund to provide a maximum of 5 regional posts over 18 months, to support much stronger integration of the Families First and Communities First programmes at a regional strategic level.

We continue to support the development of the Families First programme, encouraging shared learning and the dissemination of best practice. We held the first national learning set in January 2013, focusing on TAF. Local authorities are also required, as a condition of funding, to establish and contribute to, local and regional learning sets. This will ensure that learning from new ways of working is shared and reflected in practice.

While the reports highlight that generally care is being provided in a way that is appropriate and compassionate; each of the 12 inspections have highlighted some specific concerns in relation to the quality of care patients receive. - 2012 24 Inspections (43 Visits)
- (i) Staffing levels are set by each organisation themselves and for the Independent Healthcare settings this is described within their Statement of Purpose (SOP). This is a particularly complex and dependent upon a number of factors including patient dependency and risk. Although staffing levels are not considered in detail during every inspection by HIW, where potential issues are identified, further review(s) can be undertaken.
- (ii) As part of inspection process, HIW routinely hold comprehensive discussions with patients and staff, and carefully observe the interactions between patients and staff. They may also meet with family members or patient advocates to seek their views on the care provided. In addition to reviewing the appropriateness of the physical environment they also evaluate the adequacy of a range of documentation including patient care plans, policies and procedures, staff induction and training plans and complaint, restraint and incident records. Therefore all of HIW inspections routinely raise issues relating to quality of patient care. All HIW inspection reports can be found on www.hiw.org

Between 2008 and 2011 there was a Welsh Government dedicated budget for Mortgage Rescue and when that ended in 2011-2012 the Welsh Government provided a top slice of Social Housing Grant funding for any committed Mortgage rescue applications that had not been paid from the dedicated budget.

The mortgage rescue scheme is still in operation and it is the responsibility of local authorities to decide whether to set aside some of their Social Housing Grant (SHG) allocation if they view the scheme as a priority

In 2012/13, four local authorities are providing funding for the scheme; Blaenau Gwent, Caerphilly, Conwy and Neath Port Talbot.

The latest version, which was reviewed in partnership with stakeholders from local government and the voluntary sector, was published in 2012. It is kept under review and will be updated further as and when necessary.

The Welsh Government has also published a variety of good practice guides addressing issues such as health, offending and working with people with an Autistic Spectrum Disorder.

We remain very concerned about the potential increase of homelessness following changes to housing benefit and we are working with local authorities to help them prepare for, and manage, the impacts of changes in housing benefit. Our Homelessness Grant and Supporting People Programme funding are being used to enable local authorities to help people who are affected by the UK Government's welfare reform agenda.

Huw Lewis: Information on expenditure specifically for welfare rights organisations is not available but two of our revenue funded programmes provide vital support to individuals and households who are homeless or are at risk of becoming homelessness. Since 2008-09, the Welsh Government has allocated a total of £33.456 million of Homelessness Grant. This funding supports local government and third sector organisations to deliver support to achieve the objectives of the Welsh Government's 'Ten Year Homelessness Plan'.

Over the same period, a total of £652.524 million has been allocated through our Supporting People programme, which provides housing related support to help vulnerable people to live independently and to prevent homelessness. Over the past two years, the Welsh Government has been working with local authorities, the third sector and landlords to improve further the effectiveness of the Supporting People programme. This is being done through collaborative working arrangements based around six regions.

The Homelessness Grant and Supporting People programmes are playing an important part in helping people affected by the Westminster Government's welfare reform agenda. Since April 2011, we have allocated £1.500 million of Revenue Funding to support Wales wide activities aimed at mitigating the effects of Welfare reform.
