The latest labour market data showed employment and unemployment deteriorating, providing a clear indication that the global downturn is affecting Wales in a broadly similar fashion to the UK in general Assembly Government economists have provided relevant economic analysis at our economic summits.

Our economists have looked in detail at prior periods of economic weakness and are monitoring the international response to the global financial crisis and liaising with colleagues at HM Treasury and other Whitehall departments, to inform and provide context for advice provided to Assembly Government ministers.

The Minister for Environment, Sustainability and Housing (Jane Davidson): The Welsh Assembly Government has set an objective for all social housing in Wales to be brought up to the Welsh Housing Quality Standard (WHQS) by 2012 and to maintain it thereafter. One of the requirements in complying with WHQS is that all dwellings must be capable of being adequately heated at an affordable cost to the residents.

The Welsh Assembly Government does not set standards in relation to emergency back up systems; that level of detail will be for the individual local authority to decide. The local authority, will have a contractual obligation (via the tenancy agreement) to keep in good repair and proper working order heating provision for the building and to facilitate the provision of utilities. The majority of sheltered schemes are likely to have an on-site warden or community alarm system. In the event of a power cut these mechanisms could be used to alert the emergency repairs helpline that contingency measures are required. I presume that, particularly in areas prone to power cut in the winter (e.g. rural areas), there will be contingency plans for this type of situation. However, the responsibility for management and maintenance of sheltered schemes lies with each local authority.
