Statement by the Secretary of State for Wales on the Queen's Speech followed by a debate

NDM1731 Karen Sinclair (Clwyd South)

To propose that the National Assembly for Wales:

- 1. Notes the content of the UK Government's Legislative Programme for 2003-04; and
- 2. Commends those Bills with particular relevance to the Assembly's responsibilities to the appropriate subject committees for further consideration. Such consideration should focus on the provisions each Bill should make for Wales and how the Assembly might use its' new powers therein

Delete Point 2 and replace with:

2. Regrets the Westminster Government's failure to address the serious problems of rising crime faced by Welsh residents and the United Kingdom as a whole, in the Legislative Programme for 2003-2004.

Amendment 2 Jocelyn Davies (South Wales East)

Add as new point at end of motion:

Calls on the Welsh Assembly Government to negotiate within the UK Government to prioritise a new Government of Wales Act that would devolve primary legislative and tax varying powers to the National Assembly and in the meantime regrets the lack of influence Wales has over the inclusion of Wales only Bills due to not having a full time Secretary of State in the UK Cabinet.

Regrets the inclusion of measures to introduce top-up fees to Higher Education Institutions

- a) Making St David's Day as a Bank Holiday in Wales,
