The Minister for Health and Social Services (Lesley Griffiths): The Welsh Government is aware of the importance of short break services to disabled children, young people and their families and is already providing funding for this service.

Since 2007 £1.5million has been paid annually to Local Authorities, to promote and improve short break services. In addition, following the Coalition Government's decision to end the Child Trust Fund, we took the decision to redirect that funding to support disabled children, young people and their families through the Families First initiative. This has resulted in a dedicated strand for disability support within Families First which has been in place since April 2011, and from April 2012 will have a ring-fenced funding total of £3 million.

In 2012, we will consult in parallel with the Social Services Bill for Wales, on new measures under section 25 of the Children and Young Persons Act 2008. This will strengthen the duty on Local Authorities to provide short breaks for carers of disabled children, and will require them to publish details of the range of short break services they provide and how these are designed to meet the needs of carers in their area.

**Assembly Commissioner (Peter Black):** One employee is receiving pay protection for a period of four years due to a change of role on return from maternity leave, the only other pay protection arrangements currently in effect are those relating to the phasing out of certain allowances as part of the 2010 pay deal for employees of the Assembly Commission. The allowances being removed were frozen for a period of two years and are being phased out over the following four years.

The number of employees affected by the phasing out of each of the allowances is shown in the following table though it should be noted that some employees are in receipt of more than one of the allowances.

Allowance	Number of employees
ICT Allowance	13
Accountancy Allowance	2
Procurement Allowance	1

There are currently no plans to review these arrangements.
