**Subordinate Legislation Committee Report** 

Title: The Food Labelling (Nutrition Information) (Wales) Regulations 2009

**Procedure: Negative** 

These Regulations further amend the Food Labelling Regulations 1996 ("the principal Regulations") in so far as they apply in relation to Wales. The principal Regulations extend to the whole of Great Britain. These Regulations implement in Wales Commission Directive 2008/100/EC amending Council Directive 90/496/EEC on nutrition labelling for foodstuffs as regards recommended daily allowances, energy conversion factors and definitions ("the Commission Directive").

# Under Standing Order 15.2 the Assembly is invited to pay special attention to this instrument on the following grounds:

The Table substituted by Schedule 2 to the Regulations sets out minerals in respect of which nutrition claims may be made, both as regards the substances included and the recommended daily allowances. The Recommended Daily Amount shown for Potassium in the Regulations is 200mg. However, the corresponding amount shown in the Commission Directive being implemented is 2,000mg. [Standing Order 15.2(vi) – defective drafting]

The attention of the Assembly is also drawn to these Regulations under Standing Order 15.3(iv) as they inappropriately implement European Union legislation.
