Section 1, page 1, after line 15, insert –

- ‘() In discharging its duty under subsection (1) a local authority must –
- (a) from time to time consult the school council of any maintained school in its area which has one; and
 - (b) have regard to any view which such a school council may at any time express as to how that duty should be discharged.
- () In discharging its duty under subsection (2) a governing body of a maintained school must –
- (a) if that school has a school council, from time to time consult that school council; and
 - (b) have regard to any view which that school council may at any time express as to how that duty should be discharged.

The Welsh Ministers must from time to time issue guidance to local authorities and governing bodies as to the matters referred to in subsection (3)(a),(b) and (c). ‘.

() **Duties on the Welsh Ministers**

- (1) The Welsh Ministers must –
- (a) when exercising their functions relating to the curriculum in maintained schools; and
 - (b) when deciding whether to exercise their power to make regulations under section 7 and in what way to do so;

have regard to the aim of promoting healthy eating and drinking.'.

To insert a new Section

'() Reports by the Welsh Ministers

- (1) The Welsh Ministers must, at least once in every calendar year, lay before the Assembly a report setting out—
 - (a) the steps taken by them during the period to which the report relates to promote healthy eating and drinking in maintained schools in Wales;
 - (b) the extent to which there appears to have been an increase in healthy eating and drinking in those schools;
 - (c) any information relating to the promotion of healthy eating and drinking in maintained schools which they have received from the Chief Inspector under section 20(1)(g) of the 2005 Act during the period to which the report relates; and
 - (d) when they have asked the Chief Inspector to give advice to them under section 20(2)(a) of the 2005 Act on a matter relating to the extent to which the duties under sections 1(1) and (2) are being discharged effectively, the advice which they have received from the Chief Inspector during the period to which the report relates.'

 - (c) unrhyw wybodaeth ynghylch hybu bwyta ac yfed yn iach mewn ysgolion a gynhelir y maent wedi'i chael gan y Prif Arolygydd o dan adran 20(1)(g) o Ddeddf 2005 yn ystod y cyfnod y mae'r adroddiad yn cyfeirio ato; a
 - (d) pan fônt wedi gofyn i'r Prif Arolygydd roi cyngor iddynt o dan adran 20(2)(a) o Ddeddf 2005 ar fater sy'n ymwneud ag i ba raddau y mae'r dyletswyddau o dan adran 1(1) a (2) yn cael eu cyflawni'n effeithiol, y cyngor y maent wedi'i gael gan y Prif Arolygydd yn ystod y cyfnod y mae'r adroddiad yn cyfeirio ato.'
