As part of our work on finding a solution to fly grazing I am issuing a consultation on 4 March which seeks views on the Regulations currently in place and on how the Welsh Government might act to deliver a legal framework across Wales to help deter large scale incidents of fly grazing or abandonment of horses and ponies.

Derbyniwyd ateb i'w gyhoeddi ar 25 Chwefror 2013 Answer received for publication on 25 February 2013 **The Minister for Education and Skills (Leighton Andrews):** The 2011/12 statistical release of Pupils Educated Other than at School reported 986 compulsory school age children as being electively home educated. In 2010/11 the figure was 896. Although by definition these children are educated other than at school, education for these pupils is not funded by the local authority and there is no legal basis under which the local authority can collect personal data about them. Data on electively home educated pupils are restricted to headcounts by local authority, gender and age and are provided voluntarily by the local authority.

The Welsh Government policies that support Elective Home Education are contained in Section 6 of Circular 47/2006: Inclusion and Pupil Support guidance. This guidance also contains further links to organisations and their websites which may be useful in supporting parents who choose to educate their children at home.

Leighton Andrews: I welcome the research report "Small Voice, Big Story" undertaken by young people. It is a report that is highly relevant to the lives of young people living in poverty in Wales.

The key recommendations, including recommendation 4 which relates to "A special fund for children to "join in", to help children in poverty pay for things like books, stationery, travel and equipment to support advanced learning in after-school clubs and school trips, match evidence from other studies. We are encouraging schools to take them into account when making plans on how they spend their Pupil Deprivation Grant, where we are making some £36.8 million available this year. The Pupil Deprivation Grant is designed to help schools to break the link between poverty and low attainment. It is paid directly to school budgets to allow them to determine interventions based on local needs.

We have developed guidance for schools on effective strategies to tackle the effects of deprivation – and this valuable research will inform further guidance and workshops to be delivered later in the year.

The Minister for Health and Social Services (Lesley Griffiths): Following my announcement in December 2012 of an additional £82 million to the NHS, I have made it very clear to all Health Boards they must deliver on their statutory financial targets and achieve financial breakeven. My officials continue to work very closely with the NHS to ensure appropriate action is taken to address any remaining potential deficit or outstanding financial residual risks.

I can confirm all brokerage taken up during 2011/12 has been fully repaid in accordance with the terms on which it was provided ie £18.4 million has been repaid in 2012-13 with £6 million to be repaid in 2013-14.

The Health Boards end of year financial position, including the final resource allocation position, will be available in accordance with established procedures following the production and publication of their year end statutory accounts.

The Welsh Government has not received any formal requests for brokerage in the current year.

The Minister for Housing, Regeneration and Heritage (Huw Lewis): The local planning authority is responsible for designating conservation areas and producing local policies to guide day to day development control decisions on issues such as the installation of UPVC windows into buildings within conservation areas. Specific details about the local policies that apply to conservation areas will be available from the local planning authority.

The Welsh Government provides a national policy framework for the effective preparation of local policies by local planning authorities. For conservation areas, this is explained in Chapter 6 of Planning Policy Wales and Planning and the Historic Environment: Historic Buildings and Conservations Areas. Windows form one of the most significant constructional elements of any building and their style and proportion affect the character and appearance of elevations. Where such buildings, and their architectural detailing, contribute to the overall special character and appearance of a conservation area the local planning authority will need to carefully judge the effect of development proposals against that special interest. As a rule, the Welsh Government's guidance explains that original windows in historic buildings should be repaired, or if totally beyond repair, should be replaced exactly like for like. Double glazed UPVC windows can compromise the historic and architectural character of historic buildings because of the thickness required for the frames and detailing, and by the use of a non-traditional material. It follows, therefore, that such work may also compromise the character and appearance of a conservation area. This is however a judgement for the local planning authority in the light of the extent of work proposed and the contribution the building makes to the conservation area.
