MEMORANDUM OF CORRECTIONS PURSUANT TO STANDING ORDER 22.13

The Education (School Government)(Wales)(Amendment) Regulations 2001

Background

These draft Regulations were considered by the Business Committee on 8th May 2001, were laid before the National Assembly for Wales on 8th May 2001, and were considered by the Legislation Committee on 15th May 2001.

Minor drafting errors were identified by the Legal Adviser to the Legislation Committee prior to the draft regulations being considered by the Committee. The amendments set out below were reported to the Committee at its meeting on 15th May 2001 and agreed by it as being appropriate for correction under Standing Order 22.13.

Amendments

1. Explanatory Note

Amendment 1. The words "[... 2001]" should be deleted from the English text and replaced by the words "1st September 2001". Reason for the amendment: minor drafting error.

Amendment 2. The words "[... 2001]" should be deleted from the Welsh text and replaced by the words "1 Medi 2001". Reason for the amendment: minor drafting error.

2. Below the Heading to the Regulations

Amendment 3. The words "1st September " are missing from the English text below the heading to the regulations, in the place indicated for the coming into force date, and should be inserted. Reason for the amendment: minor drafting error.

Amendment 4. The words "1 Medi " are missing from the Welsh text below the heading to the regulations, in the place indicated for the coming into force date, and should be inserted. Reason for the amendment: minor drafting error.

3. Regulation 1(2)

Amendment 5. The words "1st September" are missing from the English text in the place indicated for the coming into force date and should be inserted. Reason for the amendment: minor drafting error.

Amendment 6. The words "1 Medi" are missing from the Welsh text in the place indicated for the coming into force date and should be inserted. Reason for the amendment: minor drafting error.
