**The Minister for Education and Skills (Leighton Andrews):** This is not the first Estyn report to raise issues of literacy. The Estyn Annual Report for 2009-10 identified 'a dislocation in how progress in literacy and numeracy is tracked from Foundation Phase through to key stage 2, across the transition to secondary school, and eventually into tertiary education.'

That is why I announced in February 2011 a clear programme to address literacy issues, including:

- a national approach to professional development in literacy through initial teacher training, induction and continuing professional development.
- A new National Literacy and Numeracy Framework (NLNF) to be introduced on a statutory basis from September 2013. The NLNF will include literacy and numeracy attainment matrices which will identify annual expected outcomes in literacy and numeracy for all learners aged 5 to 14. It will also enable schools to identify how best to support and challenge all of their learners.
- A national reading test, beginning on a voluntary basis this year and on a statutory basis from May 2013 .All learners in years 2 through to 9 will be required to be assessed using the national reading test. The tests will assess achievement holistically by including varying elements of comprehension and higher order reading skills. The tests will have a diagnostic element so that teachers will be able to undertake further investigation of the strengths and weaknesses of an individual child's attainment if appropriate.
- The continuing use of proven intervention strategies to help young people who are behind catch up

The School Standards Unit will monitor literacy as one of its key priorities. The performance management system for both headteachers and teachers will reflect literacy priorities. My department is working with the Welsh Local Government Association and local authority consortia to set targets in literacy based on their key priorities as identified in their self-evaluation.

**Leighton Andrews:** Considerable Welsh Government support is in place for Gypsy and Traveller children and more of them are now registered at schools in Wales than ever before. An annual Grant for the Education of Gypsy and Traveller Children, of £900,000 in 2011-12, aims to improve their school

attendance and encourage progression to secondary education. Used as match funding, it is attracting £2 million of ESF Priority One Convergence funding.

Welsh Assembly Government Circular 003/2008 'Moving Forward – Gypsy Traveller Education' provided comprehensive guidance to all schools. Officials are working to the recommendations of the 2011 Estyn report 'The Education of Gypsy Traveller pupils – An Update on Provision in Secondary Schools' including commissioning a new curriculum resource which will celebrate Gypsy Traveller culture. Two all-Wales conferences have been held on Gypsy Traveller education and an All-Wales Forum of local authority Gypsy and Traveller Education Co–coordinators has been set up, with whom my officials work closely.

**Leighton Andrews:** We have produced guidelines providing practical advice for school caterers on implementing changes to the food and drink provided in schools in line with the standards proposed in our Appetite for Life Action Plan. These guidelines were developed in consultation with key stakeholders and contain information on allergies and intolerances, with practical advice for schools and caterers on some of the most common food allergies and intolerances and how reactions can be avoided.

**Leighton Andrews**: Guidance on how teachers and social services should work together to ensure that pupils in schools in Wales are effectively safeguarded is outlined in "Safeguarding Children in Education" (Circular 005/2008). All schools and Further Education institutions in Wales have a senior member of staff who is designated to take lead responsibility for dealing with child protection issues, provide advice and support to other staff, liaise with the local authority, and work with other agencies. The designated person undertakes training in inter-agency working that is provided by, or to standards agreed by, the Local Safeguarding Children Board, and refresher training to keep her/his knowledge and skills up to date.

Derbyniwyd ateb i'w gyhoeddi ar 06 Chwefror 2012 Answer received for publication on 06 February 2012 **Leighton Andrews:** The School-Based Counselling Strategy was published in April 2008 and has been gradually rolled out across local authorities, with all secondary schools being covered by autumn 2010. To date grant funding of £12.5m has been made available.

An independent evaluation report from the British Association for Counselling and Psychotherapy (BACP), published in November 2011, evaluated the success of the strategy and the longer term effect of the service on children and young people. The report found that young people, teaching staff, local authorities and counsellors all expressed high overall levels of satisfaction with school-based counselling. It also strongly evidenced the role that counselling plays in helping young people achieve their potential.

Taking these findings into account, the School Standards and Organisation Bill will include legislative proposals in relation to school-based counselling. The purpose of introducing legislation in this area is to ensure that young people of secondary school age, and pupils in Year 6 in transition to secondary schools, have access to an appropriately trained counsellor who will provide formal one-to-one counselling.

**Leighton Andrews:** We have taken a number of steps to tackle homophobic bullying in schools. Last autumn we issued comprehensive new guidance on homophobic bullying to help schools and local authorities put in place mechanisms to prevent bullying and to respond to it when it occurs.

We are providing support to young people through the school-based counselling initiative and we promote programmes to manage pupils' behaviour and support their emotional development. We have made £300,000 available to local authorities this academic year for well-evaluated behaviour management training for teachers, including specific anti-bullying interventions.

My officials will continue to work with organisations like Stonewall Cymru to tackle homophobic bullying, and will be running a series of seminars across Wales in the spring to draw schools' attention to this and other forms of bullying.

The Deputy Minister for Children and Social Services (Gwenda Thomas): Young carers have been a key priority in the Carers Strategy for Wales since it was launched over ten years ago, and I will ensure

support for young carers continues to be a priority when we refresh the Strategy later this year. We have made progress in identifying and supporting carers across all ages but more needs to be done.

We have made sure that young carers' needs are fully taken into account as Local Health Boards and local authorities prepare, publish and implement their local Information and Consultation Strategies under the Carers Strategies (Wales) Measure 2010. £5.8 million has been allocated over three years for the development of these strategies, including £430,000 specifically to ensure a chapter on the information and consultation needs of young carers is included in each local strategy.

We are commissioning a toolkit specifically to help professionals throughout local authorities, NHS bodies and education and training providers to audit and improve their policies for identifying and engaging with you carers. This will include updating the 'Caring for Young Carers' training resource for schools which was originally produced in 2004. We expect this work to begin in April. The toolkit will be web based, and will be tested out with young carers and professionals to ensure that it meets the requirement.

Carers' needs are also at the heart of our Social Services Bill which will provide the legal framework to deliver our programme of transformation for social services. We fully recognise the important role that carers and especially young carers fulfil and that stronger support is needed to help them care. We will continue to ensure that all relevant stakeholders, including young carers and those organisations which work directly with them, are able to participate in shaping our policies and the services they need as we move forward with this agenda of change.

The Minister for Health and Social Services (Lesley Griffiths): Many of the recommendations from the Committee's inquiry into orthodontic services in Wales mirror the findings of an independent expert group commissioned by the Welsh Government, both of which support our current policy direction.

It was generally recognised a process for consolidating and implementing the recommendations was required to produce guidance for Local Health Boards (LHBs) and the profession on the effective and efficient commissioning of orthodontic services, including the facilitation of strategic, detailed operational management and modernisation of services. To that end, I have established a Strategic Advisory Forum to oversee this work and facilitate the implementation process.

Guidance has been issued to LHBs supporting processes and policies to improve the quality of orthodontic care, eliminate inefficiencies and share best practice. The guidance includes advice on contract monitoring and specific indicators on the level of orthodontic services delivered. Managed Clinical Networks (MCNs) have been established which will help improve efficiency and effectiveness including the management of those patients waiting for treatment. LHBs are using MCNs to create an improved referral management process by identifying patients who have been referred to more than one orthodontist and reducing early, multiple and inappropriate referrals.

**Lesley Griffiths:** Primary care orthodontics is not included in the targets set out in the Waiting Times Directive. As a result, figures for those patients waiting to access primary care orthodontic services are not held centrally.

Published Referral to Treatment Times (RTT) statistics for November 2011 show 2,383 patients in Wales were waiting for an initial outpatient appointment for orthodontics in hospital provider settings at the end of November, including 2 waiting over 36 weeks.

Lesley Griffiths: The amount allocated to each local health board in each financial year since 2003-04 is detailed in the table below. The allocations for the former 22 local health boards, which were in existence until 30 September 2009, are grouped by the seven successor local health boards established on 1 October 2009. Also included is the allocation for Health Commission Wales, which was abolished on 31 March 2010, and its allocation devolved to local health boards from 1 April 2010. Also included is the core grant allocation to Public Health Wales NHS Trust, which was established on 1 October 2009. The Welsh Government does not make core grant funding allocations to the other NHS trusts in Wales.

**Gwenda Thomas:** Improving outcomes for children and other vulnerable children remains a key priority for the Welsh Government.

The Welsh Government greatly values the role that foster carers in Mid and West Wales and the rest of the country play in providing homes and caring for some of our most vulnerable children and young people. Of the current looked after children population 80% (4310) of the children are cared for by foster carers. We are committed to supporting them for the valuable service they provide.

We do not have statistics on the number of children awaiting adoption. The use of a placement settings such as Adoption, long term fostering or a children's home, is only taken for children when all extensive steps have been exhausted to rehabilitate and reunite them with their family or extended family

Whilst I am pleased with the increase in the number of children adopted from care, to 252 children in 2011, (representing a 10% increase on the previous year), I accept, the numbers remain low and evidence still shows that adoption rates continue to be low across the UK.

In Sustainable Social Services Wales and the Programme for Government we made clear that some services are more effectively delivered nationally, we are pioneering this approach in exploring with stakeholders the remit and functions of a National Adoption Agency, this work will form part of our consultation on the Social Services Bill, which we will consult on in March. The UK Government's recent response to the review of the family justice system, which we have positively influenced, will see major reforms, including the speeding up of the court system. This will lead to earlier decisions about the future of a child and help ensure they can be found loving homes more quickly.

**Gwenda Thomas:** An Evaluation Report on the Foundation Phase of the Autistic Spectrum Disorder (ASD) Strategic Action Plan was published in February 2011. This report looked at whether the ASD Action Plan had delivered its original objectives. Its findings were that strong progress had been made in terms of putting in place an ASD infrastructure within the statutory services; the development of regional and national networks for the sharing of information and best practice; and awareness raising. A number of gaps were also identified that need to be addressed during the next phase of delivery including: data collection; mentoring support and guidance; and services for adults with ASD.

I have agreed that a consultation on the future direction of the ASD Strategic Action Plan should be opened in the summer which will draw on the findings of the Evaluation Report together with other relevant reports and research such as the Report of the Adult Task and Finish Group and the Wales

Autism Research Centre's study of children's diagnostic services. It is imperative that the consultation engages with people with ASD and their families and carers about what is important to them and what can make a real difference to their lives.

The Counsel General: No guidance is issued to Ministers on this. This is considered a technical legal drafting issue and the choice of either an order or regulations for powers to make subordinate legislation is made by Ministers on advice from the drafter of the relevant bill. The drafter will be the Welsh Government's Legislative Counsel in the case of an Assembly Bill and UK Parliamentary Counsel in the case of a Westminster Bill. There is no categorical division between these two kinds of subordinate legislation, but generally they apply to different kinds of legislative power. Regulations are used for powers to set out the details of systems established by primary legislation. Orders tend to be used to give effect to a legislative event, such as commencement of provisions in an Act or the repeal or amendment of current statutory provisions. In practice nothing much turns on whether the instrument is called an order or regulations, except that it is usually the case that the power to make one kind of instrument is not exercised in the same statutory instrument as the power to make the other kind.
