During the last Branch meeting, at which the Llywydd was present, it was queried – as part of the discussion on EOMs - what the process was for a parliament to invite Observers to its elections, aware that there had not been any such missions to observe Senedd elections up until now.

The Branch Secretariat had looked into this and the response from the BIMR was that it only observed Overseas Territories and Crown Dependencies. - *73rd Westminster Seminar*
10-14 March

- *BIMR CWP Conference*
Edinburgh, Scotland
16-19 March

Natasha Asghar MS, Rhianon Passmore MS and Sioned Williams MS would represent the Branch at this year's Regional CWP Conference, hosted by the Scottish Parliament.

- *BIMR EOM
Cayman Islands
26 April-2 May*

Alun Davies MS had been successful in gaining a place as a Short-term Observer on this mission. It was understood that there would be further EOM opportunities in the Autumn.

- *CWP Conference
Nassau, The Bahamas
28 April - 4 May*

Sioned Williams MS' application had been successful and was put forward as the Branch's nomination. Sioned Williams MS would be one of 30 CPA Parliamentarians participating in the workshop, which would focus on "*Parliamentarians of Women's Economic Empowerment*"

- *BIMR Conference
Cardiff, Wales
17-19 June (DOC 2)*

A discussion was held on the forthcoming BIMR Conference which would be hosted by the Senedd.

It was agreed that Alun Davies MS and Delyth Jewell MS (both of whom had not previously attended a BIMR) would, along with the Chair, be official Senedd delegates*

*Afternote: Sam Rowlands MS was subsequently contacted and agreed to represent the Welsh Conservative Group as a delegate at the Conference.

It was confirmed that other Members of the Branch Executive Committee, as well as the Branch Presidents (Llywyddion) would participate in numerous aspects of the Conference.

There was agreement that, amongst the themes under consideration, *the Welsh Youth Parliament; Mental Health and Wellbeing of parliamentarians; and the importance of support for LGBT+ parliamentarians* should be included as part of the programme.

- *61st Canadian Regional Conference
Quebec City
20-23 July*

The National Assembly for Quebec would this year be hosting the CPA Canada Regional Conference. In recognition of the productive relations between our parliaments, the Senedd will receive an invitation to send one Member to attend the conference as an international observer. The Branch Secretariat would advertise the opportunity to Members as soon as practical.

- *68th Commonwealth Parliamentary Conference / CWP elections
Barbados
6-13 October*

The Branch expected to receive an official invitation to the CPC in May, following the ExCo Meeting in London. Our delegate for this conference would be a woman Member but it was also hoped that the Branch would be able to accommodate the participation of an additional Member, as an Observer.

- *Commonwealth Youth Parliaments
2026/2028.*

The Chair noted that our Branch had previously expressed an interest in hosting a future CYP - and indeed the Llywydd raised this at our last meeting, following a meeting with the New Zealand Parliament to discuss their experience of hosting the 2024 conference.

The CPA Secretariat had since then been in touch to ask formally whether the Senedd would like to pursue the option of hosting in 2026.

Following a discussion, Members agreed that it would be difficult for the Senedd to undertake this commitment during an election year. Members were, however, keen to revisit this matter and to assess whether the CPA Senedd Branch could host a future CYP during the

Seventh Senedd.
