The Minister for Environment and Sustainable Development (John Griffiths): This reply addresses both questions tabled relating to TAN 6 Planning for Sustainable Rural Communities.

The 2010-2011 Rural Enterprise Dwelling monitoring returns were published to the Welsh Government web site on 19 March. 18 local planning authorities responded to the survey. Of those local authorities who responded, 9 provided planning application data and 9 gave a nil response.

Across Wales, during the first 8 months following introduction of the new policy in July 2010, 14 rural enterprise dwelling planning applications received planning permission and 12 were refused.

My officials will be writing to all local planning authorities shortly to reiterate the need to comply with the monitoring requirements set out in Technical Advice Note 6 Planning for Sustainable Rural Communities. The letter will emphasise that returns for the period April 2011 to March 2012, including nil returns, must be submitted by 31 May. The results of the second monitoring exercise will be published on the Welsh Government's web site during the summer.

**John Griffiths:** The Welsh Government is currently undertaking a review of the Building Regulations Part L (Consumption of Energy and Fuel) intended to deliver the Programme for Government commitment to improve performance of new housing by 55% on 2006 standards. The review has involved a thorough analysis of the energy consumption of new buildings and opportunities to improve existing buildings in Wales and has examined the options for achieving significant carbon reduction here in Wales. The findings and proposed changes to the Building Regulations will be consulted on in June.

The proposed changes will seek to ensure that the fabric of all new buildings in Wales goes as far as is technically acceptable to achieve significant reductions in the need to use energy to heat and cool new buildings here in Wales; before the requirement to use alternative technologies to achieve carbon savings.

The Welsh Government realises that in order to achieve significant reductions in carbon here in Wales, it is likely there will be a need for all new buildings to require an element of alternative energy generation such as Photovoltaics (PV) and air source heat pumps.

The extent to which energy will be required from on-site technologies will depend on the nature and scale of individual developments. For our work PV has been used as a 'proxy' on the basis that it can be installed in most developments. The Building Regulations sets functional performance requirements, in the case of Part L this is set in terms of carbon emissions targets and minimum levels of fabric and services performance. They do not require specific technologies, it is however expected that in order to meet our intended higher standards renewable generation is likely to be required in many cases.

The proposals we intend to consult on in June represent a first step towards both our aspiration to achieve zero carbon new development and to meet the requirements for 'Near Zero Energy' new buildings under the 2010 recast of the Energy Performance in Buildings Directive by 2020. We intend to undertake a further review in 2015/16 to build on this.

The Part L review has recognised constraints of design, specification and taken account of householder behaviour and concerns. We have considered established renewable technologies which are the subject of major retrofitting activity under both Welsh Government and UK programmes. We expect, with long term trends in fuel price increases, for the value of low carbon and energy houses to be increasingly recognised against poorer performing existing homes. Other elements of the Building Regulations and renewable energy accreditation schemes provide that installation should not increase risks to the structure or fabric of a new home. No issues of insurability have been raised; the insurance industry will be included in our proposed consultation.

The Minister for Health and Social Services (Lesley Griffiths): Since the publication of the Autistic Spectrum Disorder Strategic Action Plan for Wales in April 2008 direct grant of some £9.5m has been allocated from my budget to implement that Action Plan. A breakdown of the allocations by year and by projects is attached.

In addition, from 2007-08 the recurrent sum of £1.7m per annum has continued to be made available through the Revenue Support Grant to enable local authorities to develop specialist services for children with autism. This amounts to a further £10.2m

The Minister for Housing, Regeneration and Heritage (Huw Lewis): As part of the development and implementation of the new Heritage Bill in 2014-15, the Welsh Government will produce guidance for local planning authorities on local listing, set out criteria against which buildings can be assessed and consider any further options available for safeguarding such buildings. Workshops with external organisations and consultees on the heritage environment are under way and have included discussion of issues around local listing and controlling the demolition of locally important buildings. A formal consultation on proposals for a Bill will begin in early 2013, but these matters will be explored further in the forthcoming Thematic Bill workshops and my Heritage Conference on 19 July.
