The Minister for Health and Social Services (Lesley Griffiths): All clinicians must routinely keep up to date on the latest developments in their areas of expertise. The Welsh Government supports health research through the National Institute for Social Care and Health Research (NISCHR) which runs an open and competitive Research Funding Scheme. No research on pernicious anaemia is currently being funded through the scheme, but researchers with an interest in it are eligible to apply. NISCHR also contributes to a range of UK research programmes to which pernicious anaemia related bids may be eligible.

Lesley Griffiths: Decisions regarding testing and prescribing medication for sufferers of pernicious anaemia are the responsibility of clinicians, and based on each patient's individual circumstances. Pathology laboratories are expected to demonstrate they perform all tests in a clinically acceptable way and in accordance with rigorous quality management systems and in compliance with accreditation standards set by Clinical Pathology Accreditation UK. The prescribing of vitamin B12 is undertaken in accordance with guidance contained within the latest edition of the British National Formulary and the Summary of Product Characteristics for each individual product.
