MEMORANDUM OF CORRECTIONS (STANDING ORDER 22.13)

The Service Subsidy Agreements (Tendering) (Amendment) (Wales) Regulations 2002

Background

These draft Regulations were considered by the Business Committee on 29 January 2002, were laid before the National Assembly for Wales on 29 January 2002, and are to be considered by the Legislation Committee on 12 February 2002.

The Legal Advisers to the Legislation Committee have identified certain minor drafting errors appropriate for correction by a Memorandum of Corrections.

The corrections are as follows:

1. Explanatory Note

In the last sentence replace "any financial year" with "that financial year".

2. Footnote (b) to the Preamble

Insert, in place of the present text:

"**(b)** Section 137(1) of the Transport Act 1985 defines "regulations" in that Act as "regulations made by the Secretary of State." The powers of the Secretary of State to make regulations under section 91(1) of that Act have, in relation to Wales, been transferred to the National Assembly for Wales by the National Assembly for Wales (Transfer of Functions) Order 1999 (S.I. 1999/672)."

"**(b)** Mae adran 137(1) o Ddeddf Trafnidiaeth 1985 yn diffinio "*regulations*" yn y Ddeddf honno fel "*regulations made by the Secretary of State.*" Mae pwerau'r Ysgrifennydd Gwladol i wneud rheoliadau o dan adran 91(1) o'r Ddeddf honno, mewn perthynas â Chymru, wedi eu trosglwyddo i Gynulliad Cenedlaethol Cymru gan Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672)."
