**The Education (National Curriculum)
(Attainment Targets and Programmes of
Study in Physical Education) (Wales) Order
2000**

EXPLANATORY NOTE

(This note is not part of the Order)

The National Curriculum for Wales for physical education will be revised from 1st August 2000. This Order gives legal effect to the new programmes of study, which set out what pupils should be taught, and attainment targets for them. Details of these are set out in a document called "Physical Education in the National Curriculum" which is available from the Qualifications, Curriculum and Assessment Authority for Wales.

This Order also set out arrangements for phasing in the new National Curriculum.

Citation, commencement, interpretation and application

1.-(1) Enw'r Gorchymyn hwn yw Gorchymyn Addysg (Cwricwlwm Cenedlaethol) (Targedau Cyrhaeddiad a Rhaglenni Astudio mewn Addysg Gorfforol) (Cymru) 2000 ac, yn ddarostyngedig i baragraff (2) isod, daw i rym ar 1 Awst 2000.

1.-(1) This Order may be cited as the Education (National Curriculum) (Attainment Targets and Programmes of Study in Physical Education) (Wales) Order 2000 and, subject to paragraph (2) below, shall come into force on 1st August 2000.

(2) The provisions of this Order insofar as they relate to the fourth key stage shall come into force -

a. ar 1 Awst 2001 ar gyfer disgyblion ym mlwyddyn gyntaf y cyfnod allweddol hwnnw: a

(a) on 1st August 2001 in respect of pupils in the first year of that key stage: and

(b) ar 1 Awst 2002 ar gyfer pob disgybl arall yn y cyfnod allweddol hwnnw.

(b) on 1st August 2002 in respect of all other pupils in that key stage.

"the Document" means the document published by the Authority in 2000 entitled "Physical Education in the National Curriculum" **(d)** ("*y Ddogfen*");

ystyr "y Ddogfen" yw'r ddogfen a gyhoeddir gan yr Awdurdod yn 2000 o dan y teitl " Addysg Gorfforol yn y Cwricwlwm Cenedlaethol" **(ch)** ("*the Document*"); a

"the National Assembly" means the National Assembly for Wales ("*y Cynulliad Cenedlaethol*"); and

3. Mae'r Cynulliad Cenedlaethol yn cyfarwyddo y bydd y darpariaethau ynglŷn â thargedau cyrhaeddiad a rhaglenni astudio a nodir yn y Ddogfen yn cael effaith i'r diben o bennu'r targedau cyrhaeddiad a rhaglenni astudio ynglŷn ag addysg gorfforol.

4. Nid yw'r enghreifftiau a italeiddiwyd yn y Ddogfen (er mwyn dangos y rhaglenni astudio a ddisgrifir ynddi) yn ffurfio rhan o'r ddarpariaeth a wneir gan y Gorchymyn hwn.

2. The Education (National Curriculum) (Attainment Targets and Programmes of Study in Physical Education) (Wales) Order 1998(**e**) shall cease to apply -

(a) on 1st August 2000 in respect of pupils in the first, second and third key stages;

(b) on 1st August 2001 in respect of pupils in the first year of the fourth key stage; and

shall be revoked on 1st August 2002.

Specification of attainment targets and programmes of study

3. The National Assembly directs that the provisions relating to attainment targets and programmes of study set out in the Document shall have effect for the purpose of specifying the attainment targets and programmes of study in relation to physical education.

4. The examples printed in italics in the Document (which serve to illustrate the programmes of study described therein) do not form part of the provision made by this Order.

The Authority gave notice of the proposal to the bodies and persons referred to in section 368 (3) of the Education Act 1996 and gave them a reasonable opportunity of submitting evidence and representations as to the issues arising.

The Authority submitted its report to the National Assembly.

Section 368(5)

The Authority arranged for the report to be published.

Section 368(6) and (7)

A draft of the Order and of the associated document was published and a period of one month allowed for the submission of evidence and representations as to the issues arising.

Section 368(6) and (7)

A copy of the draft Order and associated document was sent to the Authority and to each of the persons consulted by the Authority and a period of one month was allowed for the submission of evidence and representations as to the issues arising.
