The Minister for Education and Skills (Huw Lewis): The Welsh Government remains committed to improving the standards of PE and school sport and I welcome the recently published report of the Schools and Physical Activity Task and Finish Group Physical Literacy- an all-Wales approach to increasing levels of physical activity for children and young people launched by the group's Chair, Baroness Tanni Grey-Thompson, on 24 June.

The report stated that 'the seriousness with which the Welsh Government has approached systematic and long-standing, health, well-being and educational problems is to be commended'. We are treating the group's report in a similarly systematic way and are currently considering its recommendations in the context of the wider review of the National Curriculum and assessment. I plan to make a statement on the report and next steps early in 2014 after there has been opportunity to consider the outcome of consultation with stakeholders on the report's recommendations. Consultation on the report will be held in tandem with consultation on the school curriculum review planned for the autumn.

The Minister for Health and Social Services (Mark Drakeford): The £65 million investment in orthopaedic services was issued to NHS Wales in June 2011 to improve the access waiting times for orthopaedic assessment / treatment.

As at June 2011, there were 67,655 patients waiting for orthopaedic assessment / treatment of which 5,982 had waited in excess of 36 weeks.

As at the end of June 2013, the total number of patients waiting for orthopaedic assessment / treatment had reduced to 54,726 from the end of June 2011, (a reduction of 12,929) of which the number waiting in excess of 36 weeks was 1,949 (a reduction of 4,033).

Evaluation of the impact of the monies has been, and remains, transparent during the process.

Ultimately, delivering improvements in orthopaedic services across Wales remains the responsibility of LHBs in line with the tier 1 requirements for Referral to Treatment waiting times, detailed in the delivery framework 2013/14.

I have made it clear to Health Boards that I expect them to maintain the improvements that have already been made in the first two years of the programme during 2013/14.

Public Health Wales have been working with Health Boards and the Welsh Health Specialised Services Committee to develop a national dataset to facilitate annual publication.

IPFR data are owned by the Health Boards and are not Welsh Government statistics.

Mark Drakeford: The national guidance for dealing with Individual Patient Funding Requests (IPFR) was issued in 2011. The guidance was prepared by a development group of senior healthcare professionals from across Wales and adopted by all Health Boards and the Welsh Health Specialised Services.

Membership is covered at section 6.6 of the guidance as follows:

The health board will appoint core members of the IPFR Panel which will comprise;

- Public Health Director (or deputy – Public Health Consultant with a medical background)
- Medical Director (or deputy - Associate/Assistant Medical Director)
- Director of Therapies & Clinical Science (or deputy - Assistant Director of Therapies)
- Lay Representative nominated by the Community Health Council (or deputy lay representative)
- The Chair of the Panel will usually be the Director who holds the executive lead for IPFRs in each organisation. This will be either the Public Health Director or the Medical Director.

Each organisation may also wish to appoint up to a further two panel members at the discretion of the Chair of the Panel, for example a member of the Ethics Committee, a Senior Pharmacist or Primary Care Director.

Mark Drakeford: Delivering improvements in the treatment of musculoskeletal conditions is the responsibility of LHBs in Wales in line with the Service Development and Commissioning Directive for Arthritis and Musculoskeletal Conditions (issued for consultation in 2006 and published in 2007).

LHBs were set a target of a minimum of 95% compliance against the directives, and in an audit of progress against all the chronic conditions service directives, conducted in 2011, LHBs achieved 97% compliance with the Arthritis and Musculoskeletal Directive.

An important aspect of these services is pain management. The Pain Sub Group of the National Specialist Advisory Group for Anaesthetics will be conducting an evaluation of pain services within each Local Health Board over the next two months. The Advisory Group intends to report and discuss recommendations with the Welsh Government this October.

The Welsh Government takes the view that the protection of common land is a matter for all those with an interest in it and that it is appropriate for those whose interests are directly affected to take action under section 41 of the 2006 Act against unauthorised development on common land.
