**'(1) Promoting healthy eating and drinking in maintained schools**

- (1) A local authority must take action to promote healthy eating and drinking by registered pupils of maintained schools in its area.
- (2) The governing body of a maintained school must take action to promote healthy eating and drinking by registered pupils of the school.
- (3) In discharging those duties a local authority and a governing body must have regard to guidance issued from time to time by the Welsh Ministers –
  - (a) on what constitutes healthy eating and drinking;
  - (b) on appropriate action to promote healthy eating and drinking;

- (c) on how principles of sustainable development are to apply in relation to the promotion of healthy eating and drinking.
- (4) In discharging its duty under subsection (1) a local authority must –
  - (a) from time to time consult the school council of any maintained school in its area which has one; and
  - (b) have regard to any view which such a school council may at any time express as to how that duty should be discharged.
- (5) In discharging its duty under subsection (2) a governing body of a maintained school must –
  - (a) if that school has a school council, from time to time consult that school council; and
  - (b) have regard to any view which that school council may at any time express as to how that duty should be discharged.
- (6) The Welsh Ministers must from time to time give guidance to local authorities and governing bodies as to the matters referred to in subsection (3)(a),(b) and (c). ‘.
