Subordinate Legislation Committee Report

Title: The National Health Service (Charges to Overseas Visitors) (Amendment) (No. 2) (Wales) Regulations 2009

Procedure: Negative

These Regulations amend the National Health Service (Charges to Overseas Visitors) Regulations 1989 (S.I. 1989/306) ("the 1989 Regulations"). The Regulations remove Guernsey and its bailiwick and Jersey from Schedule 2 to the 1989 Regulations. Visitors from these territories to Wales will no longer be exempt under regulations 4 and 5 of the 1989 Regulations from charges for healthcare provided within the NHS.

No points have been identified to be the subject of a report under Standing Order 15.2.

The following points have been identified for reporting under Standing Order 15.3(ii):

These Regulations implement a significant change that will have the effect of making the people of the Channel Islands (158,000 people) exempt from free NHS care to which they were previously entitled when visiting Wales. The Explanatory Memorandum gives no explanation, nor makes any assessment, of the impact of these changes for Wales. In particular, there is no assessment of any potential costs or savings to Welsh Government budgets or the Welsh Block or whether there is any consequential change in the entitlement of people in Wales to health care in the Channel Islands.

The Explanatory Memorandum says that a Regulatory Impact Assessment (RIA) has not been prepared because "the legislation simply amends existing legislation." It is the view of the Committee that this is an inadequate reason for not preparing an RIA that, if accepted, would apply to the greater part of all Subordinate Legislation made by the Welsh Ministers.

The Explanatory Memorandum explains that the Regulations are being made following the UK Department of Health giving "notice on the bilateral agreement between the UK and the Channel Islands and the

amendments to the regulations is [sic] to give effect to that decision". The Committee accepts that maintaining parity with other parts of the UK, and meeting international obligations, can in themselves be sound reasons for making or amending Subordinate Legislation relating to Wales. However, in this instance, a fuller explanation of the need for Welsh Ministers to make this legislation, based upon implications for Wales, would have been desirable.
