SUMMARY OF THE WORK OF THE LEGISLATION COMMITTEE 2002-2003

FOURTH YEAR ANALYSIS:

COMMITTEE RESPONSIBILITIES: Standing Order 11.5

Standing Order 11.5 sets out grounds on which the Committee are to invite the National Assembly to pay special attention to legislation. The grounds are as follows:

- doubt as to whether the legislation is within the Assembly's powers
- the legislation appears to make unusual or unexpected use of the powers
- it is excluded from challenge in the courts
- it appears to have unauthorised retrospective effect
- its form or meaning needs further explanation
- · its drafting appears to be defective
- it fails to fulfil statutory or other legal requirements
- there appear to be inconsistencies between the English and the Welsh texts.

Before reporting to the Assembly, the Committee is, under Standing Order 11.4, required to notify the relevant Assembly Minister of this intention and invite him or her to give evidence to the Committee.

During the reporting period (September 2002 – March 2003) the Committee considered 153 pieces of legislation.


The Committee invited the Assembly to pay special attention to legislation on 37 separate occasions. In the majority of cases those defects were capable of correction by Memorandum of Correction: 25 out of total 37 occasions. In 1 case the defects were appropriate for correction in the printed version.

The reasons why the Committee invited the Assembly to pay special attention to Statutory Instruments were as follows:

drafting appeared to be defective - 20 cases

- drafting appeared to be defective and form or meaning needed further explanation - 11 cases
- there were inconsistencies between the English and the Welsh texts 3 cases
- form or meaning needed further explanation 1 case
- drafting appeared to be defective and there were inconsistencies between the English and the Welsh texts - 1 case
- drafting appeared to be defective; form or meaning needed further explanation; doubt as to whether the legislation is within the Assembly's powers and there was an unusual or unexpected use of powers – 1 case

Observations

Besides reporting formally under Standing Order 11.5, the Committee's reports to the Assembly have included observations on minor defects.

The Committee pointed out the cases where drafting could have been simplified to assist the reader on 39 occasions. Suggestions were made on the need for greater clarity on 28 occasions. Typographical errors were found in (27) cases. 4 cases contained grammatical errors.

The vast majority of submitted Orders have followed the Committee's suggestion that the use of gender specific language be avoided. Only 3 Orders were found to contain instances of gender specific language.

The National Assembly is required to produce bilingual legislation except where this is inappropriate or not reasonably practicable. 151 of the Orders submitted to the Committee were drafted bilingually, of which only 1 contained inconsistencies between the English and Welsh texts.


At present out of a total of 153 Orders considered by the Committee during the period from September 2002 to March 2003, 152 are available as final printed versions. Of these, 39 final versions fully took into account Committee suggestions; 12 final versions incorporated some of the suggestions; 22 final versions did not incorporate the suggestions; the Committee's points were taken into consideration and amendments are intended by way of an amending Order in 9 cases. The Committee did not need to make any comments in respect of 70 Orders. At the time of the writing of this Fourth Annual Report the final printed versions have not been issued as yet for 1 Order. It should be noted that relatively high percentage of printed versions that did not incorporate the Committee's suggestions (i.e., 22 final versions) was largely observed in Statutory Instruments that followed the Executive procedure (these Instruments are issued before they are seen by the Committee).

In many instances the legal advisers to the Committee had been able to comment on early drafts of legislation. This has resulted in a considerable number of drafting and similar points being rectified prior to formal submission of the legislation to the Committee.

Procedures By Which Legislation Is Made

The National Assembly processes legislation in four different ways: by Standard Procedure, Executive Procedure, Accelerated Procedure and Extended Procedure. Out of total 153 Orders considered by the Committee during the period from September 2002 to March 2003, 50 cases were processed by Standard Procedure; 53 cases - by Executive Procedure; 50 cases - by Accelerated Procedure. No legislation followed Extended Procedure.

OPERATIONAL MATTERS

Legislation Committee met almost every week and had therefore very tight deadlines. However, there were no problems with the operational side. All draft orders and legal adviser reports were placed on the agenda of the meetings held soon after the date when the draft orders were laid before the Assembly. The Committee team aimed to provide Members with all papers two working days before the meeting. Following each meeting the Secretariat ensured that the Committee's Reports were laid before the Assembly as soon as possible, often on the same day. The reports and minutes were placed on the intranet and internet within two working days. All SO 11.4 letters from the Chair were sent within that time scale as well.

OTHER ACTIVITIES

VISIT TO THE OFFICE OF THE COUNSEL GENERAL

At the meeting of the Legislation Committee 9.07.02 a general question was raised regarding the procedure of drafting statutory instruments, given the fact that laid orders still seemed to contain typographical errors. The Committee decided to visit the Office of the Counsel General to gain a better understanding of the process of the legislative drafting, in the light of this concern.

Accordingly, on 5.11.02 the Chair of the Legislation Committee Mick Bates AM, Committee Members Rosemary Butler AM, Ann Jones AM, Dai Lloyd AM, Owen John Thomas AM and the Committee officials visited Office of the Counsel General and held a discussion with Assistant Counsel General Ms Angela Parkes, Senior Assembly Counsel Mr Gwyn Griffiths, Assembly Counsel Ms Catrin Huws and Senior Executive Officer Mr Alun Jenkins.

In the course of discussion it was mentioned that the OCG was grateful for constructive criticism. The Committee was given an overview of work of the Office of Counsel General and the role of the Legislation Management Unit was explained. It was explained that the difficulties faced by the lawyers were the combination of speed with which they had to create legislation in order to meet tight deadlines and the thoroughness of the preparation of the Statutory Instruments. Not always there was time to show draft legislation to the Legal Adviser to the Legislation Committee for checking beforehand. Thus typographical and similar errors sometimes still slipped unnoticed.

The Committee was briefed on the process of co-drafting of legislation simultaneously both in English and Welsh. This process involved two original texts rather than the translation of one text into another language. It was noted that the co-drafting process was longer and it involved two lawyers' working time. The resulting legislation, however, was prepared extremely thoroughly and potentially should have fewer errors. The Chair of the Legislation Committee pointed out that the National Assembly for Wales had a great desire eventually to have all its legislation co-drafted and on behalf of the Committee commended the work of the OCG on co-drafting of Statutory Instruments.

SUBMISSION TO THE RICHARD COMMISSION

On 6.12.02 the Chair of the Legislation Committee Mick Bates AM accompanied by the Committee officials appeared before the Lord Richard Commission and made a submission. The following issues were among those raised in the submission:

 Sufficiency of powers as provided by the Government of Wales Act to the Assembly to operate effectively and meet the expectations of the people of Wales: it was stressed that at the moment there is an inconsistency in an Assembly in Wales with responsibility for implementing policy without influencing it and a Parliament in London with responsibility for legislating for policy without implementing it;

- Failure of the present system to involve AMs' or wider interests in formation of bids for Westminster legislation, or in policy which lies behind bids;
- Disappointment that the UK government has not responded more positively to bids for legislation, noting that since devolution there has been only one Wales-only Act and one Bill scheduled for the coming Parliamentary session;
- Importance of conferring on the Assembly powers of primary legislation within Wales to allow the development of the political and legal capacity to give full expression to the policy requirements of Wales: examples of the use of primary legislative powers in a Wales Legislature would be such areas as Health (Free Personal Care); Education (in order to adjust tuition fees) and Animal Health.

Regarding the possible impact of increased powers, the Committee noted the following:

- If the Assembly were to receive primary legislative powers and the present structure were split into a separate Legislature and Executive, the function of making subordinate legislation would, if the Westminster and Scotland pattern were adopted, be vested in the Executive. The Committee would be reporting to the Legislature in relation to action taken by the Executive;
- The possibility of the Legislation Committee having the additional function of reporting on subordinate legislation powers in proposed primary legislation;
- The possibility of the Legislation Committee having a role in advising the Legislature on the drafting of primary legislation as introduced in the Legislature.

PRIMARY LEGISLATION SEMINAR

On 22.01.03 the Committee Secretariat and the Office of the Counsel General held a joint seminar on primary legislation. The seminar was intended for the Assembly Members, their research staff and civil servants. The seminar was very well attended. The participants found the seminar very informative and pointed out that handouts were particularly useful.

PAPER FOR BUSINESS COMMITTEE ABOUT ASSEMBLY REVIEW OF PROCEDURE'S RECOMMENDATION (PARAGRAPH 8.10 OF FINAL REPORT)

On 28.01.03 at the Plenary the Presiding Officer raised one of the Legislation Committee's recommendations to the Assembly Review of Procedure regarding

its role in ensuring that subordinate legislation procedures are being fully complied with (such as regulatory appraisal, environmental impact assessment and consultation with business). Following this, the Business Committee asked the Legislation Committee to submit its views on the implementation of this recommendation. The Committee was concerned that there was no progress with this issue and on 11.02.03 a letter to this effect was written to the Deputy Presiding Officer and copied to the Presiding Officer. As the Committee did not receive a reply, this issue was raised again in the Committee meeting during the second Assembly on 10.06.03 and another letter to this effect was written to the Chair of the Business Committee Jenny Randerson AM and copied to the Presiding Officer.

VISIT OF THE CLERK TO THE SELECT COMMITTEE ON DELEGATED POWERS AND REGULATORY REFORM CHRISTINE SALMON

On 18.03.03 the Clerk to the Select Committee on Delegated Powers and Regulatory Reform Ms Christine Salmon attended the meeting of the Legislation Committee and gave a brief presentation on the role of her Committee. This was followed by a brief presentation by the Legal Adviser to the Committee John Turnbull on the role of the Legislation Committee. After the presentation there was a discussion.

The Committee did not identify any points reportable under S.O. 11.5. It was also noted that two errors in the copy order submitted to the Committee have been corrected in the published version (i.e. incorrect date in explanatory note and incorrect year in preamble).

Under observations the Committee noted that the insertion of 28 January 2003 at the head of the regulations and in relation to, and together with, the printed signature was premature; Footnote (b) in Preamble, Regulation 1(2), Regulation 3(2) and Regulation 8 needed further clarification.

LC588 The Local Health Boards (Establishment) (Wales) Order 2003

The Committee did not identify any points reportable under S.O. 11.5. Under observations the Committee noted that Inclusion of a "made" date at the head of the order and with a signature was premature, the reference to variations in area needed further clarification, the definition of "operational date" was not in alphabetical order in the English text and Footnote (a) on page 3 should have indicated that Parts I and II of Schedule 4 were substituted by the Local Government (Wales) Act 1994.

LC589 The Local Health Boards (Functions) Regulations 2003

The Committee identified two drafting defects reportable under S.O.11.5 that were appropriate for correction by means of a Memorandum of Corrections

under S.O.22.12A: the citation of powers needed further clarification and inclusion of regulation 3(3) was inappropriate as it duplicated paragraph 13(1) of Schedule 5B to the 1977 Act and could have been construed as purporting to override 13(3). Under observations the Committee noted that some typographical points had been drawn to the attention of those responsible for the processing of these regulations, so that they could be corrected either on printing or in the memorandum of corrections.

Under observations the Committee noted that there remained some typographical errors which need to be corrected.

Under observations the Committee noted that a footnote identifying the definitions of "prescribed" and "regulations" should be inserted in section 45 of the Preamble and in Regulation 2(1) the opening wording "Unless otherwise stated" did not appear to be relevant.

The Committee identified two drafting defect reportable under S.O.11.5 that were appropriate for correction by means of a Memorandum of Corrections under S.O.22.12A: the Principal Regulations should be amended by deleting from the definition of "the Form" the words "contained in the Schedule to" and substituting - "as substituted in Schedule 1 to the Principal Regulations by"; Regulation 4 sought to revoke the whole of the 1989 Regulations except regulation 3 and the Schedule, but revocation should be confined only to regulation 4 or, alternatively, it might have been better to leave the 1989 Regulations intact. Under observations the Committee noted that Footnote (a) on page 2 needed clarification.

LC654 The Individual Learning Accounts Wales Regulations 2003

Considered by the Legislation Committee on: 11th March 2003

The Committee did not identify any points reportable under S.O. 11.5. The legal advisers to the Committee had had the opportunity to consider an early draft when some points had been identified and subsequently corrected.

LC655 The Education (Free School Lunches) (Prescribed Tax Credits) (Wales) Order 2003

Considered by the Legislation Committee on: 11th March 2003

The Committee did not identify any points reportable under S.O. 11.5.

LC656 The Education (School Lunches) (Prescribed Requirement) (Wales)
Order 2003

Considered by the Legislation Committee on: 11th March 2003

The Committee did not identify any points reportable under S.O. 11.5. The legal advisers to the Committee had had the opportunity to consider an early draft when some minor points had been identified and subsequently corrected.

LC657 The Transport of Animals (Cleansing and Disinfection) (Wales)
Order 2003

Considered by the Legislation Committee on: 11th March 2003

The Committee identified one drafting defect reportable under S.O.11.5: subparagraphs (a) and (b) of the Article 1(3) needed the change of format to clarify that the enabling provisions in sections 87 and 88 provided for the separate extension of each definition. Under observations the Committee noted that the word "must" was used inappropriately in Articles 3(1) and 4(1).

LC658 The Animal Gatherings (Interim Measures) (Wales) Order 2003

Considered by the Legislation Committee on: 11th March 2003

The Committee did not identify any points reportable under S.O. 11.5. Under observations the Committee noted that it would assist the user if the date of cessation was included in the Explanatory Note; paragraph 2(2) of the Schedule contained one case of gender specific language.

LC659 The Care Homes (Wales) (Amendment) Regulations 2003

Considered by the Legislation Committee on: 18th March 2003

The Committee identified one drafting defect reportable under S.O.11.5 that was appropriate for correction by means of a Memorandum of Corrections under S.O.22.12A: in the Regulations 5A(4) and (5) inserted in Regulation 2(3) the three "Health Authority" references should be "local health board". Under observations the Committee noted that in Regulation 2(2)(b) punctuation was amended in an unusual way.

LC660 The Health and Social Care Act 2001 (Commencement No. 5) (Wales) Order 2003

Considered by the Legislation Committee on: 18th March 2003

The Committee did not identify any points reportable under S.O. 11.5. Under observations the Committee noted that Footnote (a) needed clarification – it should have indicated that "the relevant authority" was defined in section 66.

LC661 The National Assistance (Residential Accommodation) (Disregarding of Resources) (Wales) Regulations 2003

Considered by the Legislation Committee on: 18th March 2003

The Committee did not identify any points reportable under S.O. 11.5. Under observations the Committee noted that the Footnote to the Preamble needed clarification.

LC662 The National Assistance (Residential Accommodation) (Additional Payments, Relevant Contributions and Assessment of Resources) (Wales) Regulations 2003

Considered by the Legislation Committee on: 18th March 2003

The Committee identified some drafting minor defects reportable under S.O.11.5 that were appropriate for correction by means of a Memorandum of Corrections under S.O.22.12A: Citation of Powers should have included section 22(5) of the National Assistance Act 1948; Regulation 6(2) and Regulation 6(2)(b) needed clarification.

LC663 The Education (Remission of Charges Relating to Residential Trips) (Wales) Regulations 2003

Considered by the Legislation Committee on: 18th March 2003

The Committee did not identify any points reportable under S.O. 11.5.

LC664 The Miscellaneous Food Additives (Amendment) (Wales)
Regulations 2003

Considered by the Legislation Committee on: 18th March 2003

The Committee did not identify any points reportable under S.O. 11.5.

LC665 The Disease Control (Interim Measures) (Wales) Order 2003

Considered by the Legislation Committee on: 18th March 2003

The Committee did not identify any points reportable under S.O. 11.5. Under observations the Committee noted that the cessation date should be mentioned in the Explanatory note and in there was a misprint in Article 13(2).

LC666 The Local Health Boards (Transfer of Property, Rights and Liabilities) (Wales) Order 2003

Considered by the Legislation Committee on: 18th March 2003

The Committee identified four drafting defects reportable under S.O.11.5: Paragraph (2) of Article 6, Article 8(1), Schedules 1 and 2 and Schedule 3 needed further clarification. Under observations the Committee noted that Preamble, Footnote (a) and Schedules 1 and 2 contained a drafting defect, Article 2(1) contained typographical mistakes. It was considered that these defects should be corrected by an amending order as soon as possible.

LC667 The National Assistance (Assessment of Resources) (Amendment) (Wales) Regulations 2003

Considered by the Legislation Committee on: 18th March 2003

The Committee identified seven drafting defects reportable under S.O.11.5 that were appropriate for correction by means of a Memorandum of Corrections under S.O.22.12A: the wording "in each instance" needed to be included into Regulation 2(3); the words "Social Security" should have been omitted from Regulation 3; the word "(General)" should have been omitted from the definition of "lone parent" in Regulation 3; the year of the Act should be inserted into other definitions in Regulation 3; the words "regulation 16 of" should have been included in Regulation 4; the reference to the Assembly should be in full and the

year should be given for the Local Government Act in Regulation 7(1); "Social Security" should be omitted from paragraphs (a) and (b) in the inserted paragraph 6A and the year should be given for the Local Government Act in the inserted paragraph 22 in Regulation 8. Under observations the Committee noted that, given the desirability of avoiding different text for the same paragraph as between Wales and England, Regulation 4 needed further clarification; coming into force date needed to be checked in a revised laid version of these regulations ("in accordance with article 1(1)").

LC668 The National Assistance (Sums for Personal Requirements) (Wales) Regulations 2003

Considered by the Legislation Committee on: 18th March 2003

The Committee did not identify any points reportable under S.O. 11.5. Under observations the Committee noted that the wording under the Explanatory Note contained a small drafting defect.

LC669 The Fostering Services (Wales) (Amendment) Regulations 2003

The Committee did not identify any points reportable under S.O. 11.5. The legal advisers to the Committee had had the opportunity to consider an early draft when some points had been identified and subsequently corrected.

The Committee identified some minor drafting defects reportable under S.O.11.5 that were appropriate for correction by means of a Memorandum of Corrections under S.O.22.12A: Regulation 1(1) contained an inappropriate reference to paragraph (d) of regulation 2 of the Functions Regulations; the wording "may be varied" was not appropriate in relation to sub-paragraph (b) in Regulation 2(4); the reference to "paragraph (2)(c)" was inappropriate in Regulation 7(3)(c); the wording at the end of sub-paragraph (a) of paragraph 2 of Regulation 8(1) should be "or"; "national review" should be "national service review" in Regulation 9(1); "regulation 2(1)(f)" should be "regulation 2(f)" in Regulation 21(1), (2). Under observations the Committee noted that Regulation 1(3) contained two drafting defects; Regulation 11(a) contained a grammatical error; Regulation 16(2)(5)(a) contained gender specific references; footnote in Regulation 22 needed clarification.
