Mae'r Rheoliadau hyn, sy'n gymwys i Gymru'n unig, yn diwygio Rheoliadau Hadau (Ffioedd) 1985 (fel y'u diwygiwyd). Mae'r diwygiad yn darparu ar gyfer codi ffioedd am archwiliadau gan arolygwyr cnydau a samplwyr hadau (rheoliad 2).

These Regulations, which apply only to Wales, amend the Seeds (Fees) Regulations 1985 (as amended). The amendment provides for fees to be charged for examinations for crop inspectors and seed samplers (regulation 2).
