The Minister for Education and Skills (Leighton Andrews): Many programmes within the education and skills portfolio support the universal provision of education. An underlying principle of all this funding is that all children and young people, and especially those who face socio-economic disadvantage, should fully realise their potential. Recognising that, in the past, the education system may have let down some of these disadvantaged learners, I have established the School Standards Unit to ensure that all children and young people are enabled to achieve the highest educational standards. In order to reinforce this principle, I have identified tackling the impact of poverty on educational outcomes, along with raising standards of literacy and numeracy, as one of the government's three priorities for school effectiveness.

In 2011-2012, Local Government received over £4.004 billion through the settlement to fund key core services, including education. One of three categories of indicators used to determine education formulae within that grant relates to deprivation. As a result, within that sum, we have notionally allocated £223.8 million on the basis of deprivation-related indicators.

In addition, for this financial year, Foundation Phase funding is £91 million, of which we weight 8.7% on the basis of free school meals entitlement as a proxy for deprivation. The Primary School Free Breakfast Initiative and School Milk Scheme, which particularly benefit disadvantaged learners, provide an additional £10.7 million and £2.4 million respectively.

The School Effectiveness Grant directly supports my three priorities for education in Wales. The formulae we use to determine grant allocations include weighting to reflect the numbers of free school meal pupils in each local authority. The grant strategies that we have agreed with local authorities ensure that an appropriate proportion of the total £25.6 million of the total grant funding targets socio-economically disadvantaged learners. Similar deprivation factors also apply in respect of 14-19 Learning Grant funding, which has made £20.62 million available.

The National Planning and Funding System is providing £438 million to support post-compulsory learning in Wales. Within this budget, there are deprivation allowances of £3.9 million for sixth forms in school, £14.4 million for further education institutions and £0.2 million for Welsh for Adults and Higher Education in Further Education. In addition, in 2012-2013, Jobs Growth Wales will provide an additional £12.5 million (with an anticipated £12.5 of match funding from the European Social Fund) to create employment opportunities for unemployed 16 to 24 years. This initiative will particularly benefit disadvantaged young people.

I am aware that some specific groups face particular difficulties in accessing appropriate education and making progress towards employment. These groups include looked-after children, care leavers, minority ethnic learners, gypsy and traveller children, and the disabled. So, I have ring-fenced £1 million of the School Effectiveness Grant, each year, for looked after children. The Minority Ethnic Achievement Grant provides £9.6 million, with another £0.9 million being available through the Specific Grant for the Education of Gypsy and Traveller Children. Both of these grants provide match funding for European Social Fund Priority One Convergence projects in West Wales and the Valleys: the Minority Ethnic Language Achievement Project and the Gypsy Traveller Learning and Future Employment Project.

In respect of Higher Education, we apply the principle that access should be on the basis of potential to benefit rather than the ability to pay. To that end, we are supporting higher education and student finance as follows: the Assembly Learning Grant (£96.9 million), the tuition fee grant (£35.6 million), Education Maintenance Allowance (£25.8 million), part-time grants and fees (£13.9 million), targeted grants (£16.4 million), Financial Contingency Grant (£8 million) and tuition fee and maintenance loans (£268 million).

Professor Alma Harris also has offered advice on the programme and we have shared our thinking with Michael Fullan Professor Emeritus at the Ontario Institute for Studies in Education at the University of Toronto, Andy Hargreaves Thomas More Brennan Chair in the Lynch School of Education at Boston College, Dylan Wiliam Professor Emeritus of Educational Assessment, Institute of Education, Ben Levin (previously Deputy Minister of Ontario) and currently Professor of Education at the University of Toronto and Professor David Reynolds at the Southampton Education School, University of Southampton. We have seconded Emmajane Milton from Duffryn Infants School in Newport to lead a task and finish group focusing on the detailed content and high quality resources to support those on the Masters programme. We have not yet finalised the membership of the task and finish group.

Leighton Andrews: Figures for Welsh domiciled students who completed an initial teacher training (ITT) course provided through higher education institutions (HEIs) in Wales and gained Qualified Teacher Status (QTS) in 2009/10 show that for those whose teaching activity was known six months after graduation, 995 were in a teaching post. Of these, 795 were in Wales, 195 in England and 10 elsewhere (figures will not sum because of rounding).

A number of Welsh domiciled students each year undertake ITT at English HEIs. For these ITT completers in 2009/10 whose teaching activity was known six months after graduation, 260 were in a teaching post. Of these, 70 were in Wales, 185 in England and 5 elsewhere.

The information on the destinations of Welsh domiciled students who complete an ITT course provided through HEIs in Wales and gain QTS is provided by the Higher Education Statistics Agency. It does not record the reasons for particular employment locations. Numbers of ITT completers from Welsh HEIs have always taken up a teaching post elsewhere in the UK or overseas and for many this will have been a matter of choice. It is likely that Welsh domiciled students who undertake ITT at English HEIs would tend to consider teaching posts in England as a option of choice.

This data set is a snapshot of employment at about six months after graduation and thus does not reflect long term outcomes of qualifiers. These figures will change over time. Data is not available for all students completing an ITT course as the information comes from a voluntary survey; for Welsh domiciled ITT completers in 2009/10 there was an overall response rate of 84 per cent.

The Minister for Health and Social Services (Lesley Griffiths): The funding of £0.75m referred to is in relation to the implementation of the Mental Health Measure. The funding which has already been committed to support implementation and delivery of the Mental Health Measure for the current financial year is just over £1.2 million.

As care and treatment planning has been a requirement for the effective delivery of secondary mental health services for a number of years, the introduction of a statutory requirement will necessitate the refocusing of existing care planning processes rather than the introduction of something completely new. The additional resource for Part 2 of the Measure is therefore one off funding to ease transition from one process to another with no ongoing costs anticipated.

Following the agreement of the final budget, I can confirm from 2012-13 the implementation of the Measure will be supported by £5.5m per annum of Welsh Government funding: £3.5m to support

implementation and running costs for local primary mental health support services under Part 1, and £2m to support the expanded Independent Mental Health Advocacy Service under Part 4.
