The Minister for Environment and Sustainable Development (John Griffiths): The written statement I provided on 17th January gave high level costs for ICT change. The capital cost for ICT in the current year is approximately £6.0 million and the revenue cost is £3.8 million. For 2013/14, the comparable costs are now £6.6 million and £2.3 million.

For FC shared services, the costs are: £1.75 million for ICT and business system access and support (including GIS), £0.8 million for technical services and residual charges for corporate services.

I have announced the pension scheme for the body and I am confident that this will offer staff a high quality pension for the future. We have agreed the terms upon which the scheme will be implemented with Cabinet Office and EA and we are now in negotiation over the detailed costs and implementation process. This is currently a fluid situation and I will provide a more detailed response once these negotiations have completed.
