COMPANY THAT MADE FM DOCUMENTARY RECEIVED WELSH GOVERNMENT FUNDING

It has come to light that the company that commissioned and produced the documentary on former first minister of Wales REDACTED final months in office received Welsh Government funding.

The BBC documentary on former Labour First Minister REDACTED AM, "Being First Minister" was produced by Wildfame Productions – a sub-company of the Flame Media Group from Australia.

In 2016, the Flame Media group was awarded an undisclosed sum of money by business finance Wales to establish a division in Cardiff.

Plaid Cymru'r REDACTED AM said that there had been a 'clear conflict of interest' and the documentary would not be able to sufficiently hold the First Minister to account.

Plaid Cymru AM REDACTED said,

"Recent accusations of crony culture in Welsh public life will resound with many people who feel Labour's grip on Welsh society is overbearing.

"Here, they will see a media company that received funding from the Welsh Government making a fly-on-the-wall documentary about the outgoing First Minister

"The conflict of interest is clear and it begs the question how tough a ride REDACTED got from the film makers and whether it was able to sufficiently scrutinise him."

"We still do not know how much funding Wildflame Productions received from Welsh Government. I will be tabling a written question to seek urgent clarification from Welsh Government.
