Lesley Griffiths: Coverage statistics provide a more accurate reflection of the proportion of women who have been screened in a given time period. It is coverage statistics that are published for this screening programme.

Published coverage data for this screening programme provides rates for specific age groups for Wales as a whole, but by Health Board covers the full cohort of 20-64 year olds.

Latest available data shows that Wales' coverage rate for 20-64 years olds has increased slightly over the past 3 years - 2008/09 at 75.5%, 2009/10 at 76.5% and 2010/11 at 76.4%. The coverage rate for Betsi Cadwaladr LHB in 2010/11 was 76.4% and the rate for all 20-24 year olds in Wales was 54.0% (from Cervical Screening Wales, KC53/61/65 Statistical Report 2010/11).

Public Health Wales is working with health boards to improve participation in the cervical screening programme by working with organisations such as Tenovus and Jo's Trust to promote cervical screening. Examples include a Facebook page, YouTube channel, visiting universities and information accessible at venues such as sexual health clinics, nightclubs and colleagues. There are also activities planned for the forthcoming Cervical Awareness Week.

A legally induced abortion must be certified under one or more of the following grounds:

A risk to life of woman

B to prevent grave permanent injury to physical or mental health of woman

C risk of injury to physical or mental health of woman (pregnancy not exceeding 24th week)

D risk of injury to physical or mental health of existing children (pregnancy not exceeding 24th week)

E substantial risk of child being born seriously handicapped

F in emergency – to save life of woman

G in emergency – to prevent grave permanent injury to physical or mental health of woman

The above categories are used for brevity; the full definition of statutory grounds, together with further background information, appears in the DH annual statistical bulletin 'Abortion Statistics, England and Wales'.
