The European Commission has a major programme to develop Maximum Residue Levels (MRLs) to protect short and long term impacts on human health for all the active substances used as pesticides on all significant crops. These Regulations will implement Commission Directive 2004/59/EC and Commission Directive 2004/61/EC.

 Motion to approve under Standing Order 24.25 The Food Labelling (Amendment) (Wales) Regulations 2004 (1 min)

These Regulations apply to the labelling of foods to which salatrims have been added voluntarily as an alternative to 'conventional' fats. Salatrims are a group of reduced-energy fats developed for use as an alternative to 'conventional' fats.

 Motion to approve the Anti-Social Behaviour Act 2003 (Commencement No2 and Savings)(Wales) Order 2004 (10 mins) The Anti-social Behaviour Act gives local authorities and also registered social landlords in terms of the housing provisions more tools to deal with the various forms of anti-social behaviour that can cause disruption in our communities. Some of the provisions of the Act relate to devolved areas of responsibility, and the National Assembly will commence these separately for Wales. This commencement order specifically relates to the housing provisions under Sections 13, 14 (part), 16, 17 and 91 of the Anti-social Behaviour Act 2003.

 Motion to approve the Local Authorities(Allowances for Members of Fire Authorities)(Wales) Regulations 2004 under Standing Order 24.27(iv) (10 mins)

These Regulations provide for each fire authority in Wales to make a scheme for the payment of allowances to their members and set out who should receive such allowances; the amount of the allowances; how the allowances should be uprated annually; the circumstances in which they could be witheld and reclaimed by an authority and to pay care and travel and subsistence allowances to members.
