The Deputy Minister for Agriculture, Food, Fisheries and European Programmes (Alun Davies): An independent adviser (Gareth Williams) has been gathering evidence from a wide range of internal and external interested parties through a series of meetings including one to one and group approaches and also farm visits. A Stakeholder Group representing farmers' interests met with Gareth on 29 September while a Partners Group comprising agencies and regulators met him later on the same day. Both groups are being tasked to constructively challenge existing regulations and processes with the aim of achieving a more measured and appropriate regulatory framework for the farming industry. Gareth will be meeting the groups regularly between now and the end of the year to advance this project. I have tasked Gareth to present his report of recommendations to me in December.

I will also be meeting Gareth regularly to receive updates on this work. I will make a statement on this matter as early as possible.

The Deputy Minister for Agriculture, Food, Fisheries and European Programmes (Alun Davies): Rights of common are protected by the Register of Common Land. Participation in the Glastir Common Land Element has no effect on the legitimacy or, following exit from the scheme, the use of those rights. Any requirement of a Glastir Common Land Element contract for a maximum stocking rate or a stock free period ends when the Grazing Association exits the scheme. The scheme cannot, and will not require farmers or Associations to undertake actions paid for by the scheme following their exit from the scheme. The presence of a SSSI on the common or cross compliance requirements may affect the use of any rights holders' full entitlement following exit from the scheme. These requirements apply to all graziers, irrespective of whether they have been in the scheme or not.

The Minister for Local Government and Communities (Carl Sargeant): In response to the UK Government's decision to reform Council Tax Benefit from 1 April 2013, the Welsh Government is considering all the options available to it for developing a way forward in Wales. Any options considered here would need to be linked, where possible, with other UK Government welfare reforms. In considering possible options there is, as you will appreciate, a need to ensure that the Welsh Government has the necessary powers to deliver any new arrangements. This will inevitably influence the policy option we ultimately select.
